# 2013 ONE TON STANDARD CAB AND CHASSIS

#### 16,000 Lbs Minimum GVWR - 2-Wheel Drive Dual Wheel & Dump Body

#### 1. SCOPE:

This specification covers two-wheel drive one ton chassis cab truck with a minimum of 16,000 pounds gross vehicle weight rating with service body as specified.

#### 2. APPLICABLE SPECIFICATIONS:

All federal safety regulations and State of Oregon Revised Statutes pertaining to motor vehicle construction and compulsory equipment form a part of this specification.

#### 3. GENERAL REQUIREMENTS:

- 3.1 <u>Silence of Specification</u> The apparent silence of this specification and supplemental specifications as to any detail, or the apparent omission from it of a detailed description concerning any point, shall be regarded as meaning that only best commercial practice is to prevail and that only materials and workmanship of finest quality are to be used.
- 3.2 <u>Adherence to Specification</u> Deviations to any of the requirements below shall be stated on the returned quotation. Unless so stated by the quoter, the Medford Water Commission shall assume that all requirements have been met and shall hold the quoter to each part of the specification.
- 3.3 <u>Heavy Duty</u> As applied to these specifications means that the item to which the term is applied shall exceed the usual quantity, quality or capacity supplied with standard production vehicles.
- 3.4 <u>Vehicles shall be new</u> (unused), current models of standard production, and shall be completely prepared for customer delivery through service by a factory franchised dealer prior to delivery. Quotations on "caravan" or drive-away" method of delivery from the factory to the dealers will not be considered. A new car predelivery inspection and service sheet, properly completed and signed by the service manager of the seller shall be furnished with each vehicle. Each unit shall include all inspection coupons, certicards, or warranty identification cards furnished to the trade in general in accordance with standard warranty policy. Said warranty shall be honored by all franchised dealers of that make in the State of Oregon. Said warranty maintenance required, when performed by the Water Commission preventive maintenance program, shall be acceptable to the dealers when it meets or exceeds dealer's certification requirements.

Evidence of such preventive maintenance will be furnished by the Water Commission as required by the manufacturer. Any extended warranty period customarily granted shall be made available to the Water Commission at no additional cost.

- 3.4.1 There shall be no distance limitations, not applicable to the trade in general, on either standard or extended warranty of materials and labor.
- 3.4.2 Whenever defects of major component parts clearly due to design of manufacture occur beyond the standard or extended warranty period, the The

quoter shall furnish an outline of the method of implementation of the manufacturer's standard warranty. Water Commission reserves the right to obtain adjustment on materials and labor.

- 3.4.3 The quoter shall furnish an outline of the method of implementation of the manufacturer's standard warranty.
- 3.5 All vehicles offered against this specification shall be of identical body style, quality and appointments as those offered to the trade in general during the course of the model year.
- 3.6 All accessories as listed herein shall be identical to those regularly supplied to the dealer by the original equipment manufacturer, and shall be of the identical quality and design as those normally installed on vehicles for sale through normal commercial channels.
- 3.7 Each order of vehicles shall be delivered to designated delivery point, complete with required number of invoices. Each vehicle shall be delivered with separate invoices, registration warranty papers, pre-delivery inspection sheet, and owner's manual. In any case where a vehicle is delivered minus any part, item or accessory issued as standard manufacturer's equipment, and/or as specified by the Water Commission, the vendor will be immediately notified. If the missing part, item or accessory cannot be provided and installed within 72 hours, the Water Commission reserves the right to buy the item or part from another source and bill the vendor for the cost, including installation.

# 3.8 Please Note: only one quote that best matches the requirements as listed in the Specifications will be accepted – do not submit additional alternatives – your quotation may be disqualified!

3.9 The Medford Water Commission makes every attempt to write detailed requirements based on manufacturer's specifications, wherein multiple vendors may have the opportunity to submit a quotation.
