6. Resolution No. 1959, A RESOLUTION Adopting Medford Water's Source Water Protection Plan to Protect the Water Quality and Sustainability of Our Water Resources

Water Resources & Customer Service Manager Julie Smitherman and Watershed Coordinator Arlo Todd presented Medford Water's Source Water Protection Plan (SWPP), which aims to protect the drinking water sources—Big Butte Springs (BBS) and the Rogue River. The plan identifies strategies to safeguard these resources from natural and human-related risks, such as wildfires, land use, and spills. Key objectives include improving water quality in Rogue River tributaries, reducing wildfire risks in the BBS watershed, and enhancing spill prevention. Developed collaboratively with various stakeholders and regulatory bodies, the plan is adaptable and will evolve through ongoing monitoring and assessment. Commissioner Wright asked about the location of high-risk urban industrial zones, which Todd confirmed are in White City and Eagle Point. Commissioner Dailey expressed concerns over water rights enforcement, specifically regarding Carey Pond and landowners exceeding allocations. He stressed the need for a clear policy and proactive communication with landowners. Todd acknowledged the complexities of enforcement, explaining their reliance on collaboration with the Jackson County Watermaster and

suggested renewing their intergovernmental agreement to strengthen water rights enforcement. Commissioner Strosser agreed on the importance of consistent enforcement and education. Commissioner Anderson asked about the current anchor points at the water intake. Todd explained that they use a diagonal boom to divert floating contaminants and are adding a wrapping intake. He also noted a recent \$50,000 grant from the Oregon Health Authority to buy this equipment. Commissioner Smith raised concerns about dispersed camping in restricted areas affecting the BBS watershed. Todd acknowledged the issue, citing inconsistent Forest Service enforcement due to limited resources, but mentioned ongoing advocacy for better management and offering to fund signage for restricted zones. He also noted campground closures have increased illegal camping.

Motion: Approve Resolution 1959.
