# 6. Resolution No. 1961, A RESOLUTION Awarding and Authorizing the General Manager to Execute a Contract in the Amount of \$1,733,335 with Pilot Rock Excavation, Inc. for the Construction of the Southwest Medford Infrastructure Improvements – S. Stage Road 12" Water Main Project

Medford Water seeks Board approval to execute a \$1,733,335 contract with Pilot Rock Excavation, Inc., funded by a \$2.7 million ARPA grant managed through an IGA with the City of Medford. Medford Water will deliver two water construction projects, the first of the two projects – the Orchard Home Waterline Extension – has already been completed. The project will support development and improve water pressure for 200 existing connections. The contract bid was the lowest responsive bid, and costs will be reimbursed within 10 days by the City.

#### 7. Resolution No. 1962, A RESOLUTION Authorizing the General Manager to Execute a Contract Amendment in the Amount up to \$3,179.04 with Paramount Ironworks LLC for the Big Butte Springs Line 1 Standpipe 858+51 Replacement

Medford Water entered into a \$264,497 contract with Paramount Ironworks, LLC for the Big Butte Springs Line #1 Standpipe Replacement Project, granted through Board Resolution No. 1918. Due to unforeseen constructability issues, a change order of \$3,179.04 is needed, requiring Board approval. This increases the project cost to \$267,676.04, a 1.2% rise. Capital variance funds will cover these unplanned expenses.

#### 8. Leadership Team Reports

- Finance Manager Beau Belikoff
  - GFOA Award Medford Water has received the GFOA Distinguished Budget Presentation Award for FY23/24. This award is a significant achievement, reflecting the commitment of the governing body and staff to upholding the highest principles of governmental budgeting.
- Water Resources & Customer Service Manager Julie Smitherman
  - Watershed Report Precipitation at Big Butte Springs is 100% of normal and Medford is 12% above normal for the beginning of the 2024-25 water year. Mountain snowpack is above average for this time of year and Medford temperatures for September were higher than average. Springflows at Big Butte Springs are at half flow. Willow Lake is 38% full. Rogue River Stream flows are at 1,470 cfs and is 108% of normal. Lost Creek Lake is now 39% full. Climate predictions for November show equal chances for temperature and precipitation.
- General Manager Brad Taylor
  - BRIC Grant Update Medford Water hosted FEMA representatives and an Oregon Emergency Management official for a tour of the proposed project sites, which include the Martin Control Station, Crater Lake Avenue transmission line, Merriman Road transmission (suction line), and Capitol Hill Reservoir. These interactions were productive and demonstrated strong alignment with the grant requirements. The grant will be managed as a reimbursement project, with a 90to 120-day reimbursement timeline. Medford Water is preparing to manage this financial aspect to ensure project continuity.
