OBJECTIVE:	Board Approval

### lssue

A Resolution is required to authorize the Chair of the Board of Water Commissioners to execute a Quitclaim Deed for an easement dedicated to Medford Water that is no longer needed.

### Discussion

As part of the previous Mountain Lakes Phase 1 project, portions of water facilities were installed outside of right of way in an easement recorded in Document No. 2023-024507.

A current project, Mountain Lakes Phase 2, will include dedication of right of way that will coincide with portions of the existing water line easement. The water line easement will no longer be needed by Medford Water because of this right of way dedication.

Water facilities in the portions of the easement that are outside of the new right of way have been abandoned, and the existing easement is no longer needed by Medford Water.

# **Financial Impact**

There is no financial impact to Medford Water. Recording fees for the easement and the Quitclaim Deed will be paid by the Owner.

# **Requested Board Action**

Medford Water Staff recommends a motion for approval of the referenced Resolution, authorizing the Chair of the Board of Water Commissioners to sign the Quitclaim Deed in favor of the Owner, on behalf of the City of Medford, by and through its Board of Water Commissioners as set forth in the Quitclaim Deed attached to the Resolution.

# **RESOLUTION NO. 1971**

A RESOLUTION Authorizing the Chair of the City of Medford, By and Through its Board of Water Commissioners to Execute a Quitclaim Deed Releasing All Right and Title to, and Interest in, the Easement Originally Recorded as Document No. 2023-024507 on November 28, 2023

WHEREAS, the Owner of the property at 2448 Avenue A (tax parcel 36-1W-20CA TL-400) will be dedicating right of way that will encompass existing water facilities currently within a dedicated water line easement; and

WHEREAS, the original easement will be redundant where the right of way is dedicated and will no longer be required by Medford Water; and

WHEREAS, a portion of the original easement will be outside the right of way but will no longer be needed by Medford Water; and

WHEREAS, the original easement is desired to be quitclaimed for clarity and to remove the encumbrance on the property.

BE IT RESOLVED BY THE BOARD OF WATER COMMISSIONERS OF THE CITY OF MEDFORD, OREGON, AS FOLLOWS:

The Chair is hereby authorized to sign the Quitclaim Deed in favor of the Owner, on behalf of the City of Medford, by and through its Board of Water Commissioners as set forth in the Quitclaim Deed, a copy of which is attached as Exhibit A and by reference, made a part hereof.

# QUITCLAIM DEED

The CITY OF MEDFORD, by and through its Board of Water Commissioners, GRANTOR, does hereby remise, release and forever quitclaim to IDLEWOOD LLC, an Oregon Limited Liability Company, GRANTEE, all its rights, title, and interest in and to the hereinafter described real property in the County of Jackson, City of Medford, State of Oregon.

Released Easement Area: The real property subject to the easement granted to the CITY OF MEDFORD, by and through its Board of Water Commissioners, pursuant to that certain Easement from the Grantee to the Grantor, recorded on November 28, 2023 as Document No. 2023-024507 of the Official Records of the County Clerk's Office of Jackson County, Oregon.

GRANTOR hereby agrees that the Water Easement is hereby terminated, released and discharged with respect to the Released Easement Area.

Before signing or accepting this instrument, the person transferring fee title should inquire about the person's rights, if any, under ORS 197.352. This instrument does not allow use of the property described in this instrument in violation of applicable land use laws and regulations. Before signing or accepting this instrument, the person acquiring fee title to the property should check with the appropriate city or county planning department to verify approved uses, to determine any limits on lawsuits against farming or forest practices as defined in ORS 30.930 and to inquire about the rights of neighboring property owners, if any, under ORS 197.352.
