NOTICE IS HEREBY GIVEN that the Board of Water Commissioners of the City of Medford, Oregon, will hold a public hearing on Wednesday, December 3, 2025, at 12:15 p.m., at the Medford Police Department's Prescott Room, 219 S. Ivy St., Medford, Oregon, to consider proposed water rate modifications for most customer groups served by the Medford Water system.
