- Adopted changes to System Development charges in August.
- Awarded a contract with Consor North America for consulting services to update our Water System Master Plan and our Water Management and Conservation Plan
- Issued contracts for logging services and log purchase agreements from work in the Big Butte Springs watershed consistent with our Board adopted Forest Management Plan.
